## **Your County Legislator**

My submission to the spring newsletter didn't make the issue, so I want to begin by thanking you all for the support you offered in the November election. I said from the start that in order to win the County Legislative election, I needed strong support from Scipio. I got it and I am grateful. Now that I am in office, I encourage you to contact me with your concerns, ideas, and issues.

As I took office, one of the first things that became clear is that Cayuga County is facing a very real fiscal challenge. For the past several years, the County has balanced its budget by dipping into the fund balance, that is, the savings account. This cannot go on for long since the money will soon be gone.

I am sure you have heard a lot about State mandates and how the program and cost requirements imposed on Counties by New York State make it very hard to manage the local budget. Well, it is true. Approximately 70% of the property tax collected by the County goes to fund these programs, over which the County has no control. In the long run, we must work to get the State to pick up the cost of the programs it creates. In the short run, we have to accept these costs and work in areas we can control.

This is what I will help to do.

To make certain that I am available to hear your concerns, I am holding a series of sessions in October and early November; I invite you to join me for a discussion of the issues. These will be:

*Ledyard at the Ledyard Town Office*

*Saturday October 25 at 10 AM*

*Springport at the Springport Town Office*

*Thursday, November 6 at 2 PM*

I have scheduled a mix of Saturday, night and afternoon in an attempt to accommodate schedules and you should feel free to come to any that are convenient for you. I will be available to explain any votes about which you have questions, to discuss the budget/tax situation, and to hear any and all comments and complaints (or kudos) you wish to share.

If none of these times are convenient, give me a call at 294-8070.

The issues of manure, run off and lake quality have been of concern recently and in response Mike Didio, Republican Majority Legislator leader and I are sponsoring a Community Discussion on the issue. This will be held on October 29, Wednesday beginning at 6 PM. The location is pending. Watch for more details. I'm excited to share with you that there is a recently published book with several references to Scipio, as well as to Ledyard. "The Seceders" by Alethea Connolly, is a story of the abolitionist movement as it developed in the Town of Manlius between 1834-1844. The Flemings, Wheatleys, Armwoods and other Cayuga County families are explored in this book and the author was kind enough to credit my research for some of her story. According to the birth registration form in our town ledger, Esther Wheatley was a slave born in Scipio in 1808; she worked in Manlius for most of her life and is buried with her sister's family in Ledyard.
