- 1. Supervisor Mutchler called the September 2025 meeting to order at 7:00 pm. Followed by the Pledge of Allegiance to the flag.

- **4. Resolution 2025-55** Approved the August 27, 2025 Town Board Meeting minutes with clarification on Item 9 Councilperson Allen inquired about Scipio's Town Courtroom security. The Town of Ledyard is discussing armed courtroom guards.

- **5.** Draft Addendum to Town of Scipio Zoning Ordinance Battery Energy Storage Systems. Town Board took No Action. Planning Board members attended a NYSERTA presentation on the topic. - **6.** Officers Reports
  - **a.** Assessor Supervisor Mutchler reported that the town's records will be passed over to the Director of Cayuga County Real Property Services in preparation for the new assessor, Jay Franklin, starting on October 1, 2025.
  - **b.** CEO No Report.
  - c. Clerk August 2025 disbursements to Supervisor were \$3297.00. Due to funding cuts East Hill Family Medical Center will no longer supply free COVID-19 test kits to the town. The town's website recently had a platform glitch that was corrected allowing the public to view timely posted agendas and minutes.
  - **d.** Highway Superintendent Highway staff have completed their summer shared service agreements with local towns. They finished oiling and chipping our town roads. The new salt shed blacktop has been sealed, and the salt contract is awaiting approval, so 500 ton of road salt can be ordered.
  - **e.** Attorney The town is waiting on the Administrative Judges' decision for our Petition for Party Status with the Agricola Wind Project. A motion was made by

Hart, second by Pitman to allow Attorney Eaton to appeal an opposed court decision regarding our Petition for Party Status.

The town is facing a 14% increase in the 2026 budget compared to 2025 due to increased costs and the percentage of calls from Town of Scipio residents. Jackie Dickinson, Executive Director of SCIA commented on improved communication. She was asked if SCIA plans to conduct CQI training with the Scipio Fire Department. The two groups will be in communication to set it up.
