In addition to consideration of hydrofracking and other heavy industrial activity in the Town, we will be looking at how to implement the other parts of our comprehensive plan and the goals it sets forth for the Town. This will involve a review of our zoning and other laws and procedures and will be focused on making certain those points set out in the plan as shared goals are implemented. I encourage you to go to the WEB site and have a look at the Comp Plan. If you can't access the WEB site, let Dodie know and she can help you get a hard copy. Help is needed with our review; so, please contact me if you are interested in working on implementation of any area of the plan.

Another important decision on the horizon is our role with the Southern Cayuga Instant Aid (SCIA). Elsewhere in the newsletter, you will find an article by Cindy Wilcox on the SCIA ambulance service and their request of Scipio and the other towns they serve for an increased level of support. This is a big step, the reasons for which Cindy begins to lay out for us in her article.

Because this is a major financial commitment and because any such commitment comes only through your tax dollars, the Board and I will be working over the next months to make sure you have a chance to share your thoughts. We will have information at the Transfer Station in the next few months and will have a series of opportunities for you to meet with us and with SCIA to get answers to your questions and hear your thoughts. I hope you will take advantage of the opportunities since the Board and I need your guidance.
